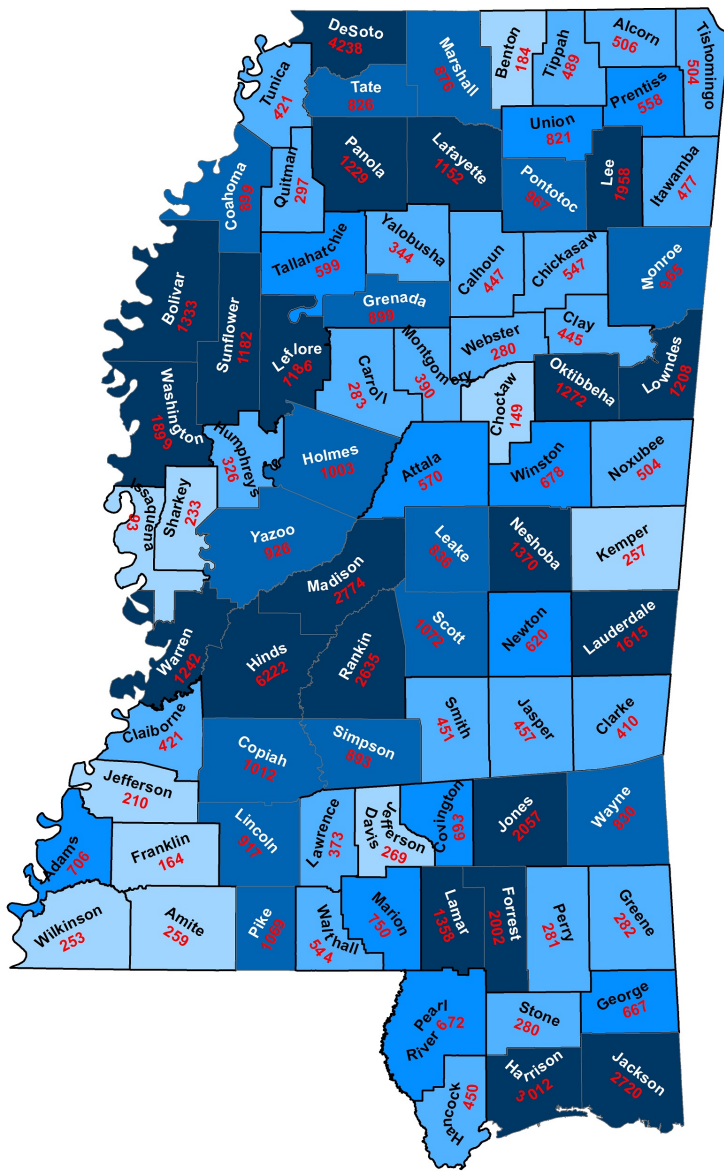

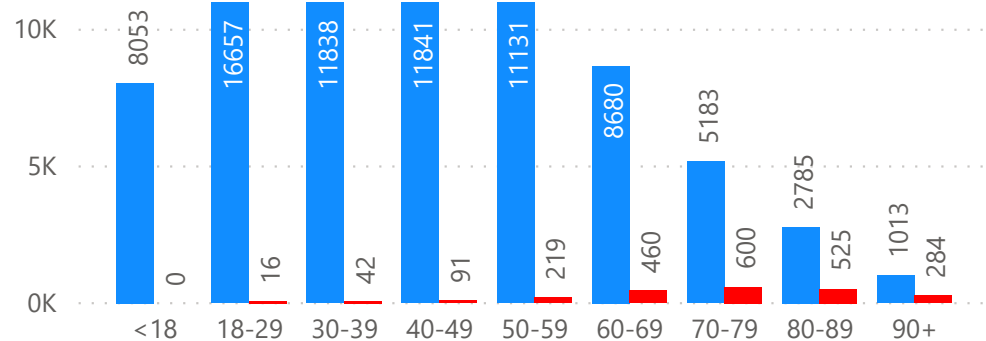
COVID-19 Cases and Deaths by Age as of 8/21/2020*

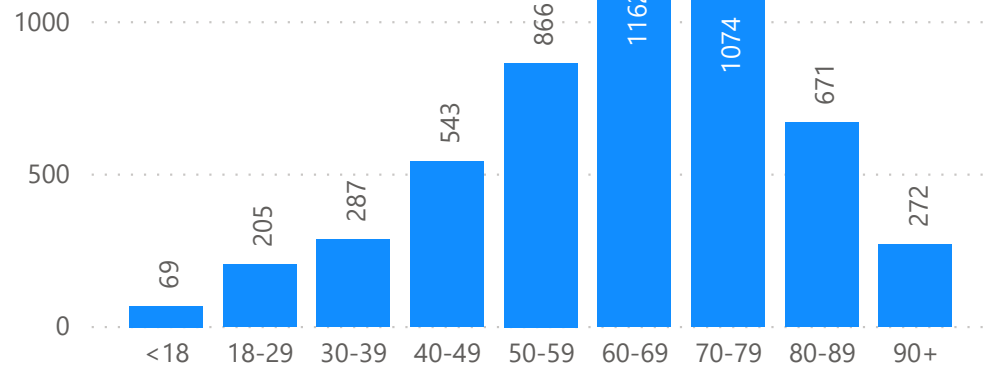

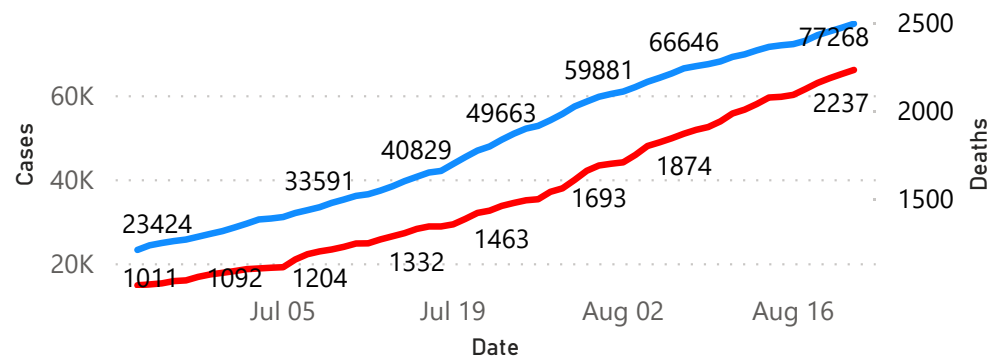
COVID-19 Hospitalized Cases by Age as of 8/21/2020*

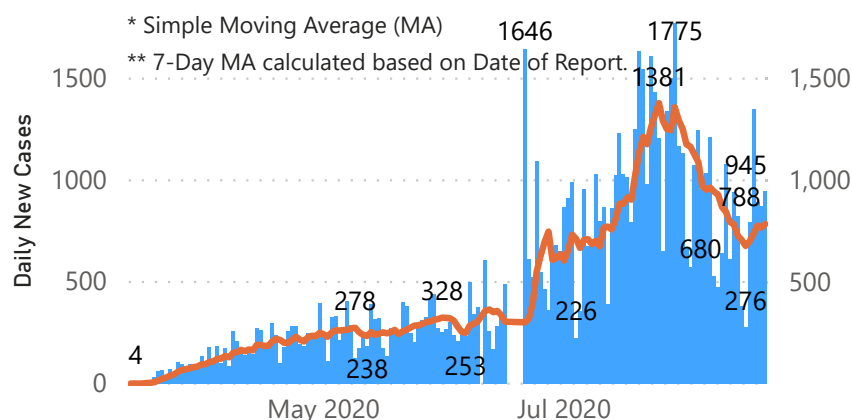
Cumulative Cases and Deaths by Date

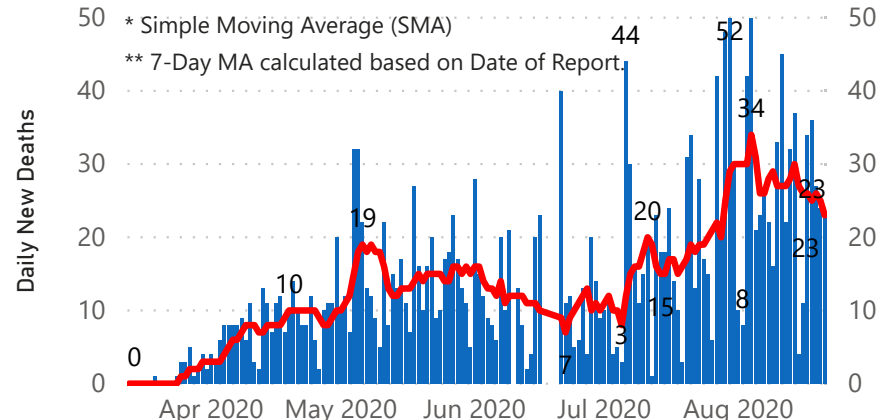
Daily New Cases with 7-Day Moving Average *,**

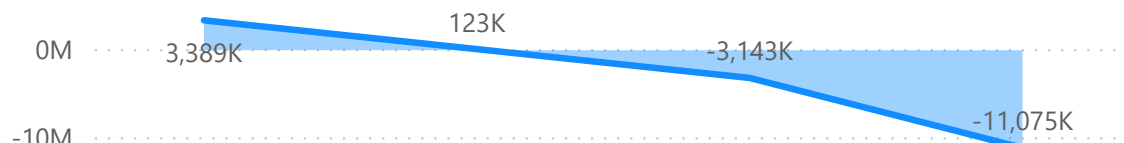

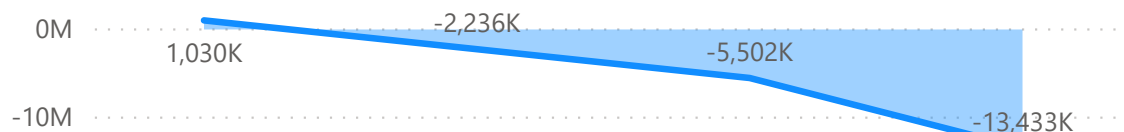
N95 Masks, Current and Prediction in 7, 14, and 31 Days



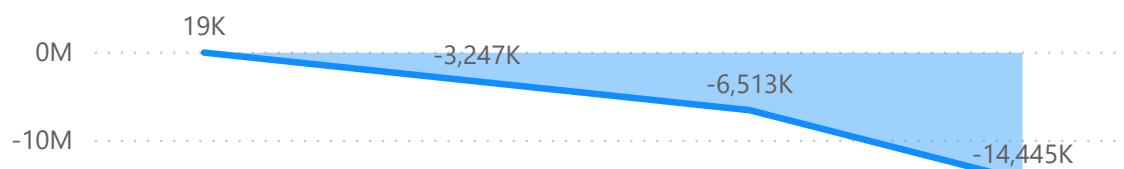
Regular Masks, Current and Prediction in 7, 14, and 31 Days



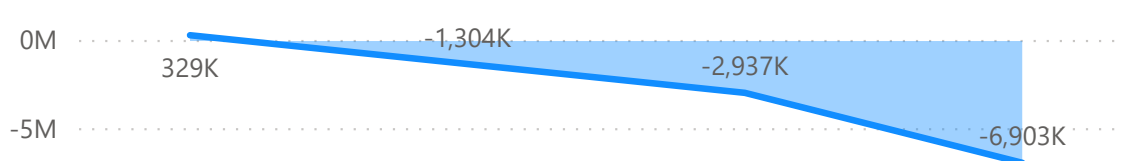
Gowns, Current and Prediction in 7, 14, and 31 Days



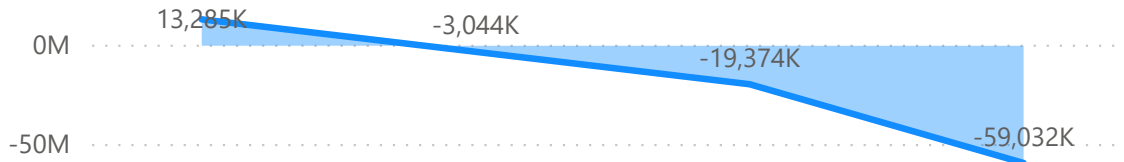
Coveralls, Current and Prediction in 7, 14, and 31 Days

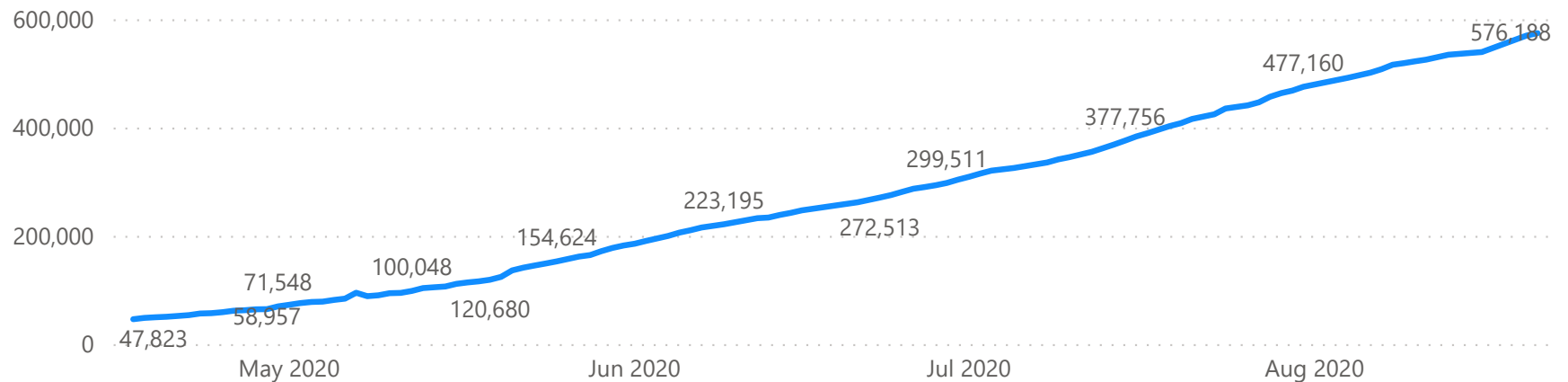

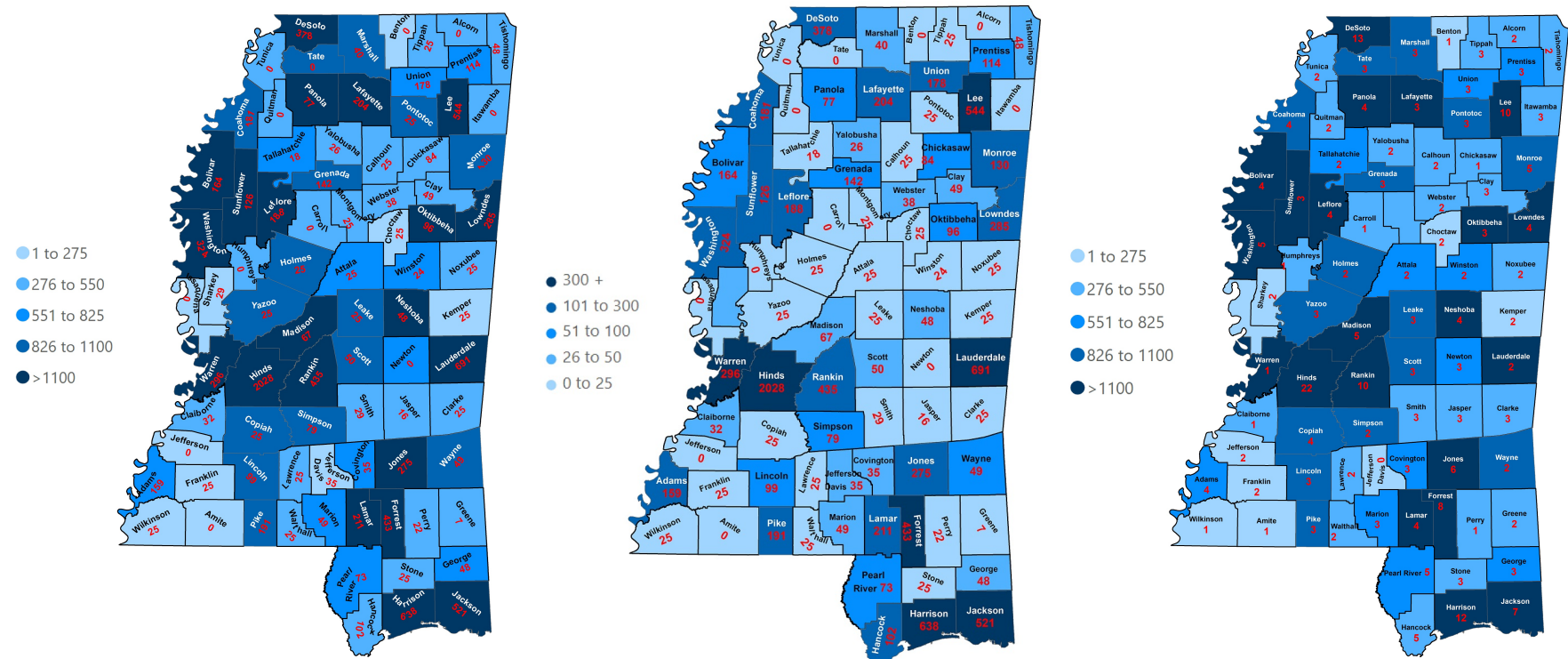

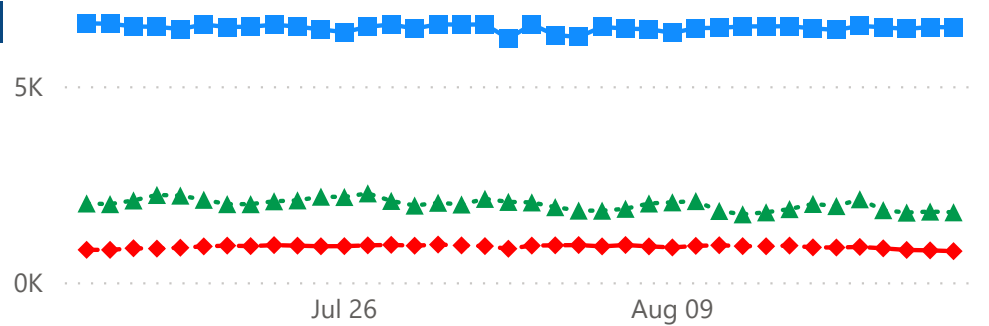

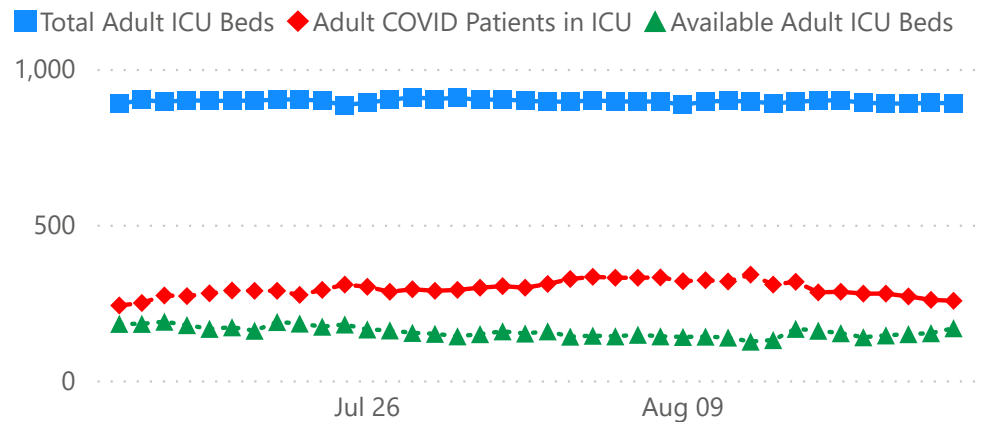
